

FINDING A FOREVER FAMILY

When Bill and Jill Akins first met, they knew they wanted to be parents someday. For the first seven years of their marriage they tried to conceive with no success. "We had given up at that point," said Bill. "We thought our dream would never come true." It was then that they decided to choose a different path to parenting -- adoption. They chose to adopt through the Massachusetts Department of Children and Families (DCF) and learned they could speed up their process by working with MSPCC. Bill and Jill began with a Massachusetts Approach to Partnership in Parenting (MAPP) training, a 30-hour educational program required of prospective adoptive parents. "The trainings were wonderful," said Jill, "[you] learn to think of the process from the child's perspective."

It was there that Bill and Jill met Sybil Turk, MSPCC's Assistant Director of Adoption Services, who guided them through the process until they finally met their daughter, Lillie. Lillie was placed in their arms at only seven months old and both Bill and Jill knew instantly that they had found their family. Jill remembers, "The minute we looked at her it was like 'This is it, this is my daughter.'" MSPCC is committed to finding permanent, loving, and stable families for society's most vulnerable children. Children who are in the custody of DCF have been removed from their biological families due to concerns of abuse and/or neglect. These children typically reside in foster homes, group homes, and/or residential treatment settings. MSPCC works with and provides training for families who are interested in adopting children, many of whom may be slightly older; present with special behavioral, emotional, and/or medical needs; or may do best with continued contact with their biological family post adoption.

When children cannot be returned to their biological families, MSPCC's Adoption Services facilitates the adoption process for these foster children by screening and providing training for prospective adoptive parents, conducting home visits, and helping to match children and families. Post-adoption, MSPCC's Adoptive Families Together offers continued training, education, and support for adoptive parents.

Parent Appreciation Celebration

ON FEBRUARY 27TH, MSPCC hosted twenty-five participants of our Healthy Families program for its first Parent Appreciation Celebration! The Healthy Families program provides support to young, first-time parents from pregnancy until their child's third birthday. Many of the participants struggle with basic needs that other parents take for granted. MSPCC wanted to provide our Bostonbased participants with some much needed pampering and baby supplies.

Parents gathered in our Boston office to find the space transformed into a selfcare sanctuary. Parents were treated to relaxing pampering, received tips on topics such as proper nutrition and child milestones, and had the opportunity to engage with community resources. The infants and toddlers were carefully supervised by Healthy Families staff. Participants took family photos, and shopped our Baby Boutique, which was stocked with everything from toys, to diapers, to clothes, to groceries.

When asked what she was most thankful for, Healthy Families Participant Tatiana said, "Everything! All the items and great people who help me...all I want to say is thank you so much for your help." Healthy Families is a voluntary and free home-based family coaching program that supports young, first-time parents and helps them create stable, nurturing environments for their children. The program matches parents with trained professionals who visit families' homes to provide support during pregnancy and the child's first three years of life.

Home visitors teach parents about proper baby care, promote nurturing and effective parenting skills, and ensure parents have a solid understanding of healthy child development. They also counsel parents on achieving personal goals related to schooling, work, and housing.

Healthy Families Massachusetts is a statewide home visiting program available for first-time parents age 20 and under, supported by the Children's Trust. Funding through the Massachusetts Home Visiting Initiative provides important service enhancements and supports to our proven home-visiting programming.




The State of the Child



MSPCC targets its children's mental health public policy goals to support proven efforts, improving capacity for early identification and treatment, and reforming practices that inhibit school success. MSPCC is a founding member and the coordinating agency of the Children's Mental Health Campaign, whose leadership includes Boston Children's Hospital, Parent Professional Advocacy League (PPAL), Health Care For All (HCFA) and Health Law Advocates (HLA). Through this coalition of more than 165 organizations, we champion children's mental health. Learn more about CMHC's 2019-2020 Legislative priorities:

An Act Relative to the Promotion of Mental Health Education



An Act Supporting Healthy Development Among Preschoolers



Rates of suspension and expulsion among preschoolers are unacceptably high in Massachusetts. In particular, black and Hispanic boys are expelled and suspended at significantly higher rates than other children. This type of disciplinary action has a lasting, negative impact on children later in life. This bill would require the Department of Early Education and Care to issue performance-based specifications aimed at restricting the use of suspension and expulsion, ensuring that when suspension or expulsion is necessary, it is free from discrimination. This bill would also encourage the use of mental health supports for children and families as an alternative to suspension or expulsion.



An Act Relative to Mental Health Parity Implementation

Mental health parity is intended to require that insurance coverage for behavioral health care is offered on the same terms and conditions as physical health care. Despite past legislative efforts, there are still barriers to behavioral health care. This bill would help to create more equitable access to behavioral health care for children and families.



An Act Increasing Consumer Transparency about Insurance Provider Networks

Families seeking care for behavioral health conditions are often hindered by out-of-date provider directories that often include providers who are no longer available. This bill would require improvements to these directories, ensuring that they are accurate and regularly updated.



An Act to Protect Children's Mental Health Services

Massachusetts is planning on terminating the court oversight of the Children's Behavioral Health Initiative, which has been resolving barriers to mental health care access. This bill would mandate the establishment of an ombuds position within the Office of the Child Advocate to ensure compliance with child mental health regulations and resolve complaints of behalf of children.
