

# **Fostering the Future**

Foster parents are absolutely critical to our child welfare system and yet, too often, find themselves and their families misunderstood. Like all parents, they provide a safe and loving home for a child to grow but with the added responsibility of caring for children who come to them with trauma, emotional scars and in need of healing and nurturing. At MSPCC, we believe that communities share a responsibility for the safety and well-being of these children, as well as a commitment to stand with those individuals who care for them.

In a recent survey conducted by MSPCC,

#### 50% of foster parents said that they only receive support from family, friends and neighbors during emergencies, with 17% saying they never receive regular support.

This lack of dependable support can impact foster parent retention and satisfaction, leaving children with fewer placement options.

With funding support from The Health Foundation of Central Massachusetts and other sources, MSPCC has brought together a diverse group of professionals and child welfare organizations to develop and pilot a foster parent support model, **Encompass: Community and Collaboration for Foster** 

*Families*, for parents and families in the Greater Worcester Area.

Encompass builds upon the strengths of a community and equips foster parents with knowledge, skills, and resources to support the needs of the children in their care –including behavioral health support, which has become even more acute during the pandemic.

The program has engaged a number of foster parents and kinship caregivers from the Worcester DCF Offices to participate in a "peer-coach-component" model that includes individualized trauma-focused information, skill building, and confidence. Following the coaching, Skill Enhancement Peer Support Program sessions will be held over a 16-week period. Over the course of the program, families are connected with Community Support Volunteers, who provide tangible support and create meaningful connections between foster parents and their surrounding communities.

MSPCC has a proud and long history of defining and shaping child welfare policy. Our direct service work informs our agenda, exposing trends in the needs and challenges of the children and families we serve.

We use our voice to engage in public policy advocacy on issues related to child and family well-being including child abuse prevention, foster care, mental health reform, and adolescent substance abuse prevention. MSPCC advocates with state leaders to ensure that the Commonwealth supports critical funding and policies to meet the needs of at-risk children and families.

But, MSPCC can't do it alone and key to successfully influencing meaningful system change is our well-earned reputation of convening a range of stakeholders to develop and implement thoughtful and compelling policy initiatives.

**MSPCC** has unique connections to foster families. Since 1997. **MSPCC** has offered the Kid's Net program, which provides a menu of supports and resources to foster families, including a calendar of more than 400 trainings each year, arrangement of respite care, a statewide network of Family Resource Liaisons to provide on-the-ground support, and an after-hours helpline. In addition, through Kid's Net, MSPCC facilitates reaular surveys of foster parents.



This newsletter showcases an exciting and innovative pilot program that demonstrates the powerful impact these collaborations can have in improving the outcomes for children. With funding from The Health Foundation of Central Massachusetts, Encompass: Community and Collaboration for Foster Families builds upon the skills and expertise of leaders in health care, state government, community-based organizations, elected officials and of course, foster parents to support foster families to better understand trauma and its effects on children in their care.

Not everyone can be a foster parent, but we all can offer support to a foster family. I hope after reading about this new initiative, you will agree that by partnering together, we make a difference in the lives of children in foster care.
